About the Dillon Scholarship:

Established in 2000, the Dillon Scholarship gives tuition support to children attending a Catholic grade school in the City of Lincoln or Pius X High School. The goal of the scholarship is to provide financial aid to the **oldest child of the family** who needs assistance in paying for the costs of a Catholic education. Only **one scholarship** will be given to each family that applies for a Dillon Scholarship with the Catholic Foundation of Southern Nebraska.

Scholarship Eligibility Requirements:

1. Meet the requirements of the Nebraska Department of Education Income Eligibility Guidelines for free or reduced price meals.
2. Maintain at least a cumulative C+ grade point average.
3. Maintain an attendance and disciplinary record satisfactory to the school administration.
4. Pay a minimum of 20% of the total tuition, book, and technology fees.
